**BUILDING PERMIT FEE SCHEDULE**

**EFFECTIVE January 1, 2015**

<b>1. Minimum Building Permit Fee</b>	<b>\$30 if construction value is less than \$500</b> <b>\$50 if construction value is more than \$500</b>
<b>2. New Single-Family, Two family</b>	<b>0.75 per. Sq. ft.</b>
<b>Residential Alterations, Repairs</b>	<b>0.50 per. Sq. ft.</b>
<b>Kitchen &amp; Bathrooms</b>	<b>0.75 per. Sq. ft.</b>
<b>3. Garages</b>	<b>0.50 Sq. ft.</b>
<b>4. Decks</b>	<b>\$50.00 plus .20 per sq. ft. over the first 100 sq. ft.</b>
<b>5. Chimney</b>	<b>\$50.00</b>
<b>6. Fireplaces</b>	<b>\$75.00 per fire place</b>
<b>7. Roofing/Siding Residential</b>	<b>\$50.00 plus \$7 per \$1000 per construction value</b>
<b>8. Windows Residential</b>	<b>\$40.00 up to four units, \$5.00 each additional unit</b>
<b>9. Fences</b>	<b>\$50.00</b>
<b>10. Foundation</b>	<b>0.45 per. Sq. ft.</b>
<b>11. Foundations Only</b>	<b>\$150.00 (not inclusive of the building permit fee)</b>
<b>12. Finished Basement</b>	<b>0.50 Sq. ft.</b>
<b>13. Accessory Buildings</b>	<b>\$50 plus .20 per sq. ft. over the first 100 sq. ft.</b>
<b>14. Multi-Family</b>	<b>1.50 per. Sq. ft.</b>
<b>15. New Commercial</b>	<b>1.50 per Sq. ft.</b>
<b>16. Commercial Alterations</b>	<b>1.50 per. Sq. ft.</b>
<b>17. Commercial Windows</b>	<b>\$60.00 up to four units, \$6.00 each additional unit</b>
<b>18. New Industrial</b>	<b>0.75 per Sq. ft.</b>
<b>19. Industrial Alterations</b>	<b>0.75 per Sq. ft.</b>
<b>20. Roofing/Siding Commercial/Ind.</b>	<b>\$100.00 plus \$7 per \$1000 of Construction value additional unit</b>
<b>21. Signs 1-60 Sq. ft.</b>	<b>\$70.00</b>

| 27. Demolition Residential           | \$75.00                                    |
| 28. Demolition Commercial/Industrial | \$200.00                                   |
29. A re-inspection fee of up to \$50.00 may be charged for any inspection called for but not ready
- 30. ALL FEES ARE TO BE STRUCTURED AT A MINIMUM OF .5 of 1% OF THE TOTAL COST OF THE PROJECT**
31. Permit life -- 6 months to start expires in 2 years from permit date
32. A 6 month extension may be requested in writing the fee is \$30 and you are allowed only two extensions at the discretion of the Building Commissioner

**Note:** On exceptionally large or complicated multifamily, commercial or industrial projects, PLAN REVIEW FEES may be required.

**Specialty Permits:** All fees are to be structured at a minimum of 1% of the total cost of the project

1. Mechanical Permit
2. Sheet Metal Permit
3. Solar Permit
4. Cell Towers

**IN ADDITION TO THE PERMIT FEE, A PENALTY OF UP TO DOUBLE THE FEE WITH A MAXIMUM OF \$300 WILL BE CHARGED IN ANY CASE WHERE CONSTRUCTION HAS BEGUN BEFORE A PERMIT IS ISSUED.**

**NOTE:** Building permits DO NOT include plumbing, gas or electrical permits. Those will need to be pulled separately.
