You are hereby notified that a Public Hearing is scheduled for Wednesday, October 3, 2012 at 8:15 PM in the Town Hall, 32 Main Street, Lower Level Meeting Room, by the Ashburnham Zoning Board of Appeals as prescribed in The Zoning Act, Chapter 40A of the Mass General Laws.

**SUBJECT:** The application of Harold and Elissa Dandy for a Finding and a Special Permit from Section 1.4 Non-Conforming Buildings and Structures and Section 1.42 Alteration and Enlargement of the Ashburnham Zoning Bylaws. The request is to lift and reposition two encroaching accessory structures from their abutter's property and place them onto their own property but to do that they do not meet the side yard setback requirements. The finding and special permit is to include all other necessary zoning relief on the property located at 44 Hilltop Drive, Map 56 and Parcel 78 in the R-B Zoning District to place the accessory structures onto their property.
