

**Minutes of the Zoning Board of Appeals
February 27, 2008**

**Hearing: #08-01

1. David Perry opens, introduces Board.
 - a. Explains procedure
 - b. Explains rules of Hearing
2. Greg Reynolds explains what he would like to do.
 - a. Starts with expansion of home (1.42)
3. Donna Brooks asks about distance from lake.
4. Cheryl Anderson asks about proposed distance from lot lines.
5. David Perry asks about “mean grade”.
6. David Perry asks Board if
7. Terry Girouard makes motion that 1.42 applies.
 - a. Second – Donna Brooks
 - b. Vote – Unanimous to find that 1.42 does apply and that a Special Permit may be granted if so voted.
8. Abutter Mr. Mark Dymek asks about Finding vote and requests Board to place conditions on any permit to address problems with common driveway shared by three abutters during construction if any.
9. Mr. Reynolds continues with request: garage asking for Variance from 4.2.
10. Joseph Daigle asks about two primaries on the lot.
11. Terry Girouard questions Joseph Daigle on two primaries.
12. David Perry asks about mean grade of garage.
13. Cheryl Anderson discusses not allowing bathroom in garage.
14. David Perry read letters from abutters and entered into record, page 1 of 3 – The DeConinck’s, page 2 of 3 – pictures of existing structure, page 3 of 3 – The Clark’s.

15. David Perry opens Hearing to abutters for comments.
 - a. Mr. Dymek state no problem with garage
 16. David Perry closes Hearing and explains rules of appeal process at 8:15pm.

 - c. Vote: Unanimous to grant with conditions

4. Board decides to continue deliberation on garage until next scheduled meeting.
5. Cheryl Anderson makes motion to continue.
 - a. Second – Donna Brooks
 - b. Vote – Unanimous
